Sanford USD Medical Center offers three ASHP-accredited PGY1 Pharmacy Residency positions. The program is a 12-month commitment with an approximate start date of July 1. Residents are mentored throughout the year and grow personally and professionally.

STIPEND AND BENEFITS

The stipend is competitive and updated annually. Residents are provided paid health and vision insurance and 20 days of Allowed Time Away (ATA), which are separate from paid holidays off. All required travel expenses are also covered.

QUALIFICATIONS AND APPLICATION

All residency candidates must meet the following prerequisites:

- Earned a PharmD degree from an accredited college of Pharmacy
- Hold an active pharmacy license, or be eligible for licensure in South Dakota

Application materials and deadline will be managed through PhORCAS:

- Letter of intent
- Curriculum Vitae
- Academic Transcripts
- Three reference submissions

Applicants considered for a position will be invited for an interview with pharmacy administration, preceptors, current residents and will be required to review and present a brief case study.
